The undersigned exhibitor does hereby apply for Swap Meet participation at the Mississippi Valley Fairgrounds. The undersigned exhibitor does hereby agree to the terms, conditions, rules and regulations as hereinafter set forth or to which reference is made for the Swap Meet at the 2024 Mississippi Valley Fair to be held August 16th and 17th, 2024 at Davenport, Iowa.

Swap Meet items limited to used automotive equipment, no new or reproduction components permitted in Swap Meet sales area. Non-automotive items subject to approval. Swap Meet exhibitors furnish their own equipment such as chairs, tables et cetera. Security service will be in effect twenty-four hours per day beginning Thursday, August 15th, however, valuable components should be removed at the close of the Swap Meet daily. Vehicle sales limited to specialty vehicles only. **SWAP MEET EXHIBITORS LIMITED TO NON-COMMERCIAL INDIVIDUALS ONLY.** Information on commercial exhibit space available on request. **NO PROMOTIONAL ACTIVITIES** (sampling, literature distribution; et cetera) **PERMITTED IN THE SWAP MEET AREA.** No overnight camping in the swap meet area.

Exhibitor expressly agrees and acknowledges that the owners and lessors of the Mississippi Valley Fairgrounds and the National Street Rod Association, Inc. and their officers, directors, employees, representatives, agents and anyone else connected with the management or presentation of the Quad Cities Street Rod Nationals are not and will not be held responsible for the goods or property of exhibitors damaged, lost or stolen or injuries or damages to exhibitors, agents, employees, guests, event participants or event spectators from any cause whatsoever while the Swap Meet is in progress – this includes the period of time property is being loaded and unloaded. Exhibitor, individually or by and through exhibitor's agents, employees, guests, assigns or heirs at law does hereby expressly waive any and all rights and claims of any nature which may arise against the National Street Rod Association, Inc., the owners and lessors of the Mississippi Valley Fairgrounds or their officers, directors, employees, representatives, agents and anyone else connected with the management or presentation and further agrees to indemnify said parties from any and all claims, demands, costs or expenses arising out of exhibitor's activities while on or about the Mississippi Valley Fair.

Subject to all conditions and agreements herein stated, exhibitor is granted the right to sell and display products and materials. No souvenir items or food and beverage may be sold, displayed or given away by exhibitors.

The Quad Cities Nationals is a Midwestern rodding sport's showcase event. Management will do all in its power to cooperate with participants, exhibitors and spectators. We ask that you please do the same. All vehicles at any/all NSRA events, must be licensed, insured and registered for the event. No motorized or non-motorized contrivances, which do not comply with these requirements, shall be ridden or driven on the grounds. Only recognized, single occupant handicap contrivances, motorized or non-motorized, will be allowed. The decision of the NSRA Officials will be final. The National Street Rod Association will endeavor to make all reasonable accommodations so that all aspects of this event are accessible to persons with disabilities. The Swap Meet Coordinator and/or the National Street Rod Association, Inc. reserve the right to revoke acceptance of this agreement at any time. NSRA is not responsible for refunds to violators of this agreement. Upon having to eject a Swap Meet exhibitor from the Swap Meet area for agreement violations, the NSRA has the right to confiscate issued event credentials from anyone violating this agreement.

Exhibitor expressly agrees that jurisdiction over any disputes arising under this agreement or any cause of action relating to the activities of the exhibitor, Swap Meet Coordinator and the National Street Rod Association, Inc. shall be governed by the laws of the State of Tennessee, with jurisdiction in Memphis, Shelby County, Tennessee.

Swap Meet space(s) Pre-registration or advance reservations are first offered to last year's participants and then on a first come first come basis. No mail in reservations after July 15th, 2024. Pre-Registered Swap Meet spaces are \$30.00 per 10'x20' space, \$40 Day of Show. Fees cover both days of the event, No discount for one day. Total fees paid entitle one vehicle and one person's entry to the Swap Meet area only at the Mississippi Valley Fair. A special gate will be used for the Swap Meet Exhibitors- All Vehicles Entering the Swap Meet Gate must have a Swap Meet Sticker in the Windshield entering or within the Swap Meet area during the event, All Swap Meet Vehicles must stay in Swap Meet Area, **VIOLATORS WILL HAVE VEHICLES TOWED AT OWNER'S EXPENSE.** No subletting of spaces permitted. All vehicles and parts must be within exhibitors' space. Swap Meet Exhibitors Set-up begins at 7:30 A.M. on Thursday August 15th, 2024.
